II. OLD BUSINESS

A. Purchase of Used Fire Truck

Chief Hoerr discuss with the board on the truck found in New York. That we would need to send \$10,000 deposit to hold the fire truck and if we chose not to purchase that the \$10,000 is refundable. Have copies of all the maintenance records and pump tests. Have 79,000 miles. The price of the fire truck is \$150,000. To have it haul here from New York be about \$3,000. Chief Hoerr said that Jeff Braun and Mike Kaps would make the trip to look at the truck. Look at hotel and rental cost around \$550 plus food cost. The deposit check will need to be two days overnighted to hold truck.

Motion to approve deposit on Used Fire Truck of \$10,000 to be two days overnighted by Trustee Steele. Seconded by Trustee Noe. No further discussion. Motion carried 4-0.

Motion to approve purchase of fire truck if everything checks out not to exceed \$150,000 by Trustee Campen. Seconded by Trustee Steele. No further discussion. Motion carried 4-0.
